

**THE GOVERNOR OF JAKARTA SPECIAL CAPITAL AREA**

**DECREE**

**NUMBER 361 OF 2020**

**CONCERNING**

**THE EXTENSION OF COVID-19 DISASTER CRISIS STATUS IN THE PROVINCE OF  
JAKARTA SPECIAL CAPITAL REGION**

- Considering : a. that the outbreak of COVID-19 in the Province of Jakarta Special Capital Regio is expanding and causing many casualties, loss of property, psychological impact on the community, as well as threatening and disrupting people's lives and livelihood, so an extension of the emergency disaster response status is needed;
- b. that based on the consideration as mentioned in letter a, it is necessary to stipulate a Governor Decree concerning the extension of COVID-19 disaster crisis status in the Province of Jakarta Special Capital Region;
- In view of : 1. Law Number 24 of 2007 concerning Disaster Management (State Gazette of the Republic of Indonesia Number 66 of 2007, Supplement Number 4723);
2. Law Number 29 of 2007 concerning the Governance of the Province of Jakarta Special Capital Region as a Capital Region of the Republic of Indonesia (State Gazette of the Republic of Indonesia Number 93 of 2007, Supplement Number 4744);
3. Law Number 23 of 2014 concerning Local Government (State Gazette of the Republic of Indonesia Number 244 of 2014, Supplement Number 5587) modified several times, with the latest Law Number 9 of 2015 concerning the Second Amendment of Law Number 23 of 2014 concerning Local Government (State Gazette of the Republic of Indonesia Number 58 of 2015, Supplement Number 5679);
4. Law Number 30 of 2014 concerning the Government Administration (State Gazette of the Republic of Indonesia Number 292 of 2014, Supplement Number 5601);
5. Government Regulations Number 21 of 2008 concerning the Implementation of Disaster Management (State Gazette of the Republic of Indonesia Number 42 of 2008, Supplement Number 4828);

6. Governor Decree Number 337 of 2020 concerning the Stipulation of COVID-19 Disaster Crisis Status in the Province of Jakarta Special Capital Region.

HAVING RESOLVED

- To Stipulate : GOVERNOR DECREE CONCERNING THE EXTENSION OF COVID-19 DISASTER CRISIS STATUS IN THE PROVINCE OF SPECIALIZED CAPITAL REGION OF JAKARTA.
- ONE : Stipulate the extension of COVID-19 Disaster Crisis Status in the Province of Specialized Capital Region of Jakarta for a time period of 17 (seventeen) days started from April 3<sup>rd</sup>, 2020 until April 19<sup>th</sup>, 2020.
- TWO : Extension of the COVID-19 Disaster Crisis Status in the Province of Specialized Capital Region of Jakarta shall be carried out if situation is still in a vulnerable condition and/or meets the criteria of extension in the contingency plan for COVID-19 outbreak disaster relief in 2020.
- THREE : The budget used for the implementation of this COVID-19 Disaster Emergency Response shall be imposed from the Regional Expenditure Budget and/or other legitimate sources that are not binding in accordance with the statutory provisions.
- FOUR : This Governor Decree shall enter into effect as of April 3<sup>rd</sup>, 2020.
